Sub:- Filling up of the post of Advisor (Broadcasting & Media) on deputation on foreign service terms in TRAI [HQ], New Delhi.

Sir,

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up the post of Advisor (Broadcasting & Media) in TRAI HQ, New Delhi on deputation on foreign service terms, initially for a period of two years. The position entails work related to the non-technical aspects of broadcasting. The gamut of sector services will cover digital (and analogue) cable TV services, DTH services, IPTV services, terrestrial TV services, radio services and public broadcasting service. The work shall cover general management as well as economic and social dimensions of all forms of the media, namely, electronic, print media, internet and radio services. Economic work relating to wholesale and retail tariffs and interconnection issues will be an integral part of the officer's work. The selected officer shall be closely associated with the implementation of the digitization programme initiatives by the Government of India; this will include its progress, resolving problems, and enforcing the regulations governing the digitization. The job shall entail a certain amount of public dealing with stakeholders such as broadcasters, DTH operators, MSOs and local cable operators. The details of qualification and experience required for the post are as under:-

- The post has been exempted from the rule of immediate absorption up to 23.1.2016 by Department of Pension & Pensioners Welfare for appointment on deputation.
