- 3. The posts of Deputy Advisor/Joint Advisor and Senior Research Officer have been exempted upto 23.1.2016 and 23.05.2016 respectively from the rule of immediate, absorption by Department of Pension & Pensioners Welfare for appointment of Central Government servants on deputation.

All the Ministries/ Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the enclosed proforma (can also be downloaded from TRAI website www.trai.gov.in) along with attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately, in the event of their selection. The application should be sent in an envelope super-scribing the post applied for so as to reach the Technical Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, Jawaharlal Nehru Marg, (Old Minto Road), next to Zakir Hussain College, New Delhi-110002.
