Sub:- Calling applications for filling up the post of 'Senior Research Officer' in TRAI [HQ], New Delhi on deputation on foreign service terms.

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The Organization proposes to fill up the vacant posts of 'Senior Research Officer' **in TRAI Headquarters, New Delhi** on deputation on foreign service terms initially for a period of two years. The details of qualification and experience etc. are as under:-

(+) Age not to exceed 56 years on the date of closure of applications.
(*) The qualification would be from a recognized University/educational institute.

3. The post has been exempted from the rule of immediate absorption upto 23.05.2016 by Department of Pension & Pensioners Welfare for appointment of central govt. servants on deputation.

4. The applications which have been received in response to vacancy circulars No. 1-08/2014-A&P dated 18th June, 2014, 18th July, 2014 and 4th September, 2014 will also be considered and no fresh application is required to be submitted in those cases.

5. All the Ministries/Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the enclosed proforma (*can also be downloaded from TRAI website www.trai.gov.in*) along with attested copies of ACRs/APARs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection. The application should be sent in an envelope superscribing the post applied for so as to reach the **Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, J.L.
