Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up the post of Principal Advisor in its headquarters at New Delhi on deputation on foreign service terms, initially for a period of two years. The details of qualification and experience etc. for the said post are as under:-

(Pay II) dated 17th June, 2010, as amended from time to time. The maximum age limit for appointment on deputation basis shall in no case exceed 56 years as on the closing date of receipt of application by TRAI.

All the Ministries/Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies of Government of India are requested to forward applications in the prescribed proforma (can be downloaded from TRAI's website www.trai.gov.in) along with attested copies of ACRs/APARs for the last five years and vigilance/disciplinary clearance of eligible candidates, whose services could be placed at the disposal of the Authority immediately in the event of their selection.
