TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

The organization propose to prepare a panel of officials having the required experience for appointment as Private Secretary, Personal Assistant and Stenographer (Hindi) on deputation on foreign service terms initially for a period of two years.
