Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis and not exceeding 58 years of age.  Preference will be given to those holding any or a combination of the following:- (i) Senior managerial position; (ii) Bachelor's Degree in Telecommunication Engineering from a recognized University or equivalent; (iii) Bachelor's Degree in Electronics & Telecommunication Engineering from a recognized University or equivalent; (iv) MBA Degree from a Recognized University or equivalent; (v) Master Degree in Economics/Commerce or Doctorate Degree in Economics/Commerce.

2. This post has been exempted from the rule of immediate absorption up to 23.1.2016 by Department of Pension & Pensioners Welfare for appointment on deputation.



3. The last date for receipt of applications is now extended upto **25.06.2011**.
