The objective assessment of quality of service of the service providers, namely, M/s Aircel, Airtel, Videocon, BSNL, Idea, RTL GSM, TATA, Vodafone, Uninor, Etisalat, MTS, RCOM CDMA and TATA CDMA was conducted during the period from April, 2011 to June, 2011.
