TRAI Releases Report of the independent agencies engaged for the Objective Assessment of Quality of Service of Telecom Services in BIHAR service area.

TRAI has conducted Network audit for the assessment of Quality of Service being provided by the service providers of Cellular Mobile Service Providers during the period from April 2012 to June, 2012. The main findings of the reports are given below:-

2. Findings of the independent agency on Quality of Service

2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers namely M/s Idea, BSNL, Reliance (GSM &CDMA), Videocon, MTS, Airtel, Uninor, Vodafone, Tata Tele (GSM & CDMA) and Aircel was conducted. Service Provider's performance on the selected Key Parameters in respect of cellular mobile telephone service based on one month data verification is annexed at "A"
