Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected The functions relating to regulation of therewith or incidental thereto. Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

The organization proposes to fill up the post of Principal Advisor at its 2. Headquarter, New Delhi on deputation on foreign service terms, initially for a period of two years. The required qualification and experience for the said post are given below:-

Pay scale/ Pay Level:	Pay Level-15 in Pay Matrix as per 7th CPC [Pre-revised HAG Rs. 67000-AI@3%-79000] plus allowances such as DA, HRA etc. as per Govt. Rules.
Eligibility criteria:	Officers of the Central Govt., Central Public Sector Undertakings and Statutory and Autonomous Bodies: (i) holding equivalent post on regular basis OR , (ii) Officers in SAG with four years of regular service in that grade OR , (iii) Group A officers having twenty one years of regular service in Group 'A' of which at least four years of regular service shall be in the Senior Administrative Grade.
Essential Qualification	Essential: A Degree in Electronic Engg. and / or Telecommunications Engineering from a recognized University and possessing requisite experience in the telecommunication field.

The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17th June, 2010, as amended from time to time. The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of application in TRAI.
