Pay scale/ Pay Level:	Pay Level-15 in Pay Matrix as per 7 th CPC [Pre-revised HAG Rs. 67000-AI@3%-79000] plus allowances such as DA, HRA etc. as per Govt. Rules.
Eligibility criteria:	Officers of the Central Govt., Central Public Sector Undertakings and Statutory and Autonomous Bodies:- (i) holding equivalent post on regular basis OR , (ii) Officers in SAG with four years of regular service in that grade OR , (iii) Group A officers having twenty one years of regular service in Group 'A' of which at least four years of regular service shall be in the Senior Administrative Grade. (iv)
Essential Qualification	Essential: A Degree in Electronic Engg. and / or Telecommunications Engineering from a recognized University and possessing requisite experience in the telecommunication field.

2. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17th June, 2010, as amended from time to time. **The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of application in TRAI.**
