Vide this second reference, MIB has proposed to adopt the certain recommendations, in respect of Platform Services offered by MSOs also by appropriately replacing the word "DTH" with "MSO" and requested TRAI to furnish its views on the above proposal.
- 3. As informed vide TRAI's above referred letter dated 7 December 2020, the Authority has considered both the above-mentioned letters together. In this regard, TRAI had issued a Consultation paper on 7 December 2020 on
