

## **DIRECTION**

Subject: Direction under section 13, read with sub clause (i), (ii) and (iii) of clause (b) of sub-section (1) of section 11 of Telecom Regulatory Authority of India Act, 1997, to open the Short Code 1072 for train accident information.

**F.No.411-1/2012-I&FN-** Whereas the Telecom Regulatory Authority of India [hereinafter referred to as the Authority] established under subsection (1) of section 3 of the Telecom Regulatory Authority of India Act, 1997 (24 of 1997) (hereinafter referred to as TRAI Act, 1997) has been entrusted with discharge of certain functions, *inter alia, to ensure* compliance of license conditions; fix the terms and conditions of interconnectivity between different service providers; ensure technical compatible and effective interconnection between different service providers and to protect interest of the consumers of telecommunications service etc.;

- 2. And whereas clause 16.1 of the licence agreement for provision of basic telephone service stipulates that the licensee shall ensure adherence to the National Fundamental Plan(describing numbering and routing plan as well as transmission plan) issued by Department of Telecom and technical standards as prescribed by the Licensor or the Authority, from time to time;
- 3. And whereas the Fundamental Plan defined under the license agreement for provision of basic telephone service reads as under:-

"FUNDAMENTAL PLAN include Numbering Plan, Traffic Routing and Switching Plan and Transmission Plan issued by Department of Telecom as amended from time to time";

- 4. And whereas clause 23.3 of the licence agreement for provision of unified access services provides that the licensee shall ensure adherence to the National Fundamental Plan which includes National Numbering, routing and transmission plan issued by Department of Telecommunications and technical standards as prescribed by licensor or the Authority, from time to time;
- 5. And whereas the Authority vide its Direction No. 101-1/2005-MN dated the 6<sup>th</sup> January, 2005 directed all service providers that when the codes are allotted by the Department of Telecommunications to a service provider, these codes should be immediately(not exceeding ten days) opened by all interconnected service providers in their network and compliance may be reported within a week;
- 6. And whereas in the National Numbering Plan issued by the Department of Telecommunications, the short code '1072' has been declared as unrestricted category-I for train accident information;
- 7. And whereas Department of Telecommunications, vide their letter no.14-3/2002-BSH dated the tenth June 2003 (annexed as **Annexure I**), informed the service providers that the short code 1072 has been allocated for train accident information and directed them to open the said number as toll free in SDCA wherever there is an accident and required by the concerned authorities;
- 8. And whereas Ministry of Railways, vide their letter No. 2002/tele/AR/7 dated the 19<sup>th</sup> December 2011 (annexed as **Annexure II)** informed the Authority that the short code is not available on any of the telecom service provider other than BSNL and even on BSNL network, it is not available at many places through STD;
- 9. And whereas the Authority vide its letter No.411-1/2012-I&FN dated the 13<sup>th</sup> January 2012 (annexed as **Annexure –III**), brought the contents of the aforesaid letter of Ministry of Railways to the notice of all Basic Service providers and directed them to send comments on Ministry of Railways' letter, referred to in the preceding para, and send compliance by the 20<sup>th</sup> January, 2012, of the instructions issued by the Department of Telecommunications vide their letter dated the 10<sup>th</sup> June, 2003;
- 10. And whereas from a copy of letter dated 26.3.2013 received from West Central Railway (annexed as **Annexure-IV**), it is seen that the

facility of short code '1072' is not being made available by the service providers;

- 11. And whereas non availability of short code '1072' will adversely affect the interest of the consumers and proper information cannot be disseminated to public whenever train accident occurs.
- 12. Now therefore, in exercise of the powers conferred upon the Authority under section 13, read with sub-clauses (i), (ii) and (iii) of clause (b) of sub-section (1) of section 11 of the TRAI Act, 1997, in order to ensure compliance of terms and conditions of licence, regulate the telecommunication services, and ensure the quality of service so as to protect interest of the consumers of telecommunications service and ensure orderly growth of the telecom sector and for the reasons mentioned in the foregoing paragraphs, the Authority hereby directs all access service providers to open the short code 1072 in its network for train accident information, as unrestricted i.e. these services shall be available from anywhere national and international, within 7 days of the issue of this direction and furnish compliance report by 31st July, 2013.

Note:- Unrestricted means, it is accessible on STD/ISD and Category-I means mandatory for service provider. All these entergeticy service numbers are to be treated as toll from numbers in local area i.e. Short Distance Charging Area.

Necessary steps be taken to open these numbers in SDCAs where ever there is an accident & request by concerned authorities.

Sub: Regarding non-compliance of DoT's instructions by Basic

Service Providers.

Ref: DoT's letter no. 14-3/2002-BS II dated 10.06.2003.

Vide letter under reference above, DoT had allocated the short code 1072 for Train Accident Enquiry. This is an unrestricted category I service and is supposed to be available on STD/ISD network of all telecom service providers. This number is also to be treated as toll free in SDCA. 1072 is a very important number and is used to disseminate information to public when an accident occurs.

Almost all the Railways have represented to this Ministry that this short code is not available on any of the telecom service provider other than BSNL. Further, even on BSNL network, it is not available at many of the places through STD.

This Ministry has issued instruction to all its zonal Railways to enhance their efforts to co-ordinate with all the local service provider to have the number 1072 opened in their network. Despite continuous liasioning and chasing with local service providers zonal Railways have failed to achieve this in the past several gears when the 1072 service was commissioned. It is therefore, strongly fell that, provide push for opening the 1072 by service provider, intervention of DoT needed.

It is therefore, requested that DoT reiterate its instructions to all the service providers to open 1072 in their network in co-ordination with the zonal Railways.
