Corrigendum to the Recommendations on "Reserve Price for auction of FM

Radio Channels" dated 10th April 2020

1. Ministry of Information and Broadcasting (MIB) vide its letter dated

22nd August 2019 sought recommendations of the Authority on fresh reserve

price for 283 cities (260 new +23 existing), under FM phase -III Policy in

terms of Section 11 (1) (a) of TRAI Act.

2. The Authority sent its Recommendations on "Reserve Price for auction of FM

Radio Channels" to MIB on 10th April 2020.

3. MIB vide its letter dated 25th June 2020 sought clarification on certain

issues on the TRAI's Recommendations dated 10th April 2020. MIB has also

sought Reserve Price of one channel in Chennai. Accordingly, TRAI issued

this Corrigendum which should be read with Recommendations on "Reserve

Price for auction of FM Radio Channels" dated 10th April 2020.

4. As regards determination of Reserve Price for Chennai, it is observed that the

issue of lack of data points as was the case with Kolkata is also applicable to

Chennai. Apart from Chennai, the reference price is only available for one A+

city viz., Mumbai. It may be noted that as detailed in paragraphs 2.19 and

2.21 of the Recommendations dated 10th April 2020, even in standard

methodology, the data was adjusted with the identification and elimination

of outliers. This was considered necessary to ensure that the Reference Prices

and corresponding valuations are representative of the overall city/state dynamics.

In the instant case, with only one relevant Reference Price (other than Chennai itself), the results obtained are not likely to be reflective of actual dynamics. Notwithstanding the same, in order to further explore the possibilities, the general revenue trends of Chennai and Mumbai from years 2015-16 to 2018-19 have been compared and it is observed that revenue for Chennai is almost around half of that of Mumbai. Under the circumstances, it is felt that the RP of Chennai would be significantly overestimated by the reference price of Mumbai if standard methodology is followed for determination of RP for Chennai. The same may not be appropriate considering the overall objective of the exercise of determination of RPs and also considering the overall approach followed and considering significant differences in general trends of revenue of Chennai and Mumbai.

As such, it would be appropriate to consider the past successful bid price of Chennai viz., Rs.5339 as the RP for the upcoming auction. Accordingly, the Reserve Price for FM Radio channel in Chennai is recommended as Rs. Rs. 5339 Lakh.

5. While analysing the issues for providing clarification sought by MIB, TRAI reviewed the recommendations and revised the Reserve Prices of the following cities:
