Subject: Direction under section 13, read with sub-clause (i) of clause (b) of subsection (1) of section 11, of the Telecom Regulatory Authority of India Act, 1997 (24 of 1997) regarding submission of periodical reports on revenue and usage.

RP-5/6/(1)/2022-FEA-II - Whereas the Telecom Regulatory Authority of India (hereinafter referred to as the "Authority"), established under sub-section (1) of section 3 of the Telecom Regulatory Authority of India Act, 1997 (24 of 1997) (hereinafter referred as the "TRAI Act, 1997"), has been entrusted with discharge of certain functions, inter alia, to ensure compliance of terms and conditions of licence; regulate telecommunication services; notify rates for telecommunication service; protect the interest of service providers and consumers of the telecom sector;

2. And whereas the Authority, in order to discharge the functions under the TRAI Act, 1997, monitors the performance of the telecom service providers (hereinafter referred to as "TSPs") on a regular basis and accordingly, the Authority, vide its Direction No. 303-2(3)/2018-F&EA dated 13th June, 2018, inter alia, directed all TSPs to submit the report on revenue & usage to the Authority, on quarter basis, within forty five days from the date of the end of respective quarter, except fourth quarter of the financial year for which the report shall be submitted within sixty days from the date of the end of the quarter, in Format-A (for wire-line services), Format-B (for limited mobility services) and Format-C (for full mobility services) annexed with the said Direction;

3. And whereas the Department of Telecommunication has amended the Unified Licence Agreement, wherein the Format of 'Statement of Revenue' and 'License Fee' for Access services has been revised and the term Applicable Gross Revenue (ApGR) has been included before the Adjusted Gross Revenue (AGR), and accordingly, the Authority has decided to revise the Formats for submitting the report on revenue and usage;

Now, therefore, in exercise of the powers conferred upon it under section 13, read with sub-clause (i) of clause (b) of sub-section (1) of section 11, of TRAI Act, 1997, the Authority, in supersession of Format-A (for wire-line services), Format-B (for limited mobility services) and Format-C (for full mobility services) annexed to the Direction No. 303-2(3)/2018-F&EA dated 13th June 2018, hereby directs all the TSPs to submit quarterly report on revenue and usage to the Authority within forty five days from the end of each quarter, except the fourth quarter of the financial year for which the report shall be submitted within sixty days from the end of the quarter, in the revised Format-A (for wireless services) and Format-B (for wireline services) annexed with this Direction. The reports may also be sent electronically to e-mail ID <u>fa@trai.gov.in.</u>
