Section 2: Instructions to Tenderers

- 2.1 Tenders in sealed cover superscribed as Tender for Supply of 74" Range Ultra HD Slim LED Display for TRAI as per "Schedule of Requirements & Conditions of Contract" as indicated in Section 4 in this tender and in accordance with instructions to Tenderers are to be submitted to The Senior Research Officer (GA), Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, Near Zakir Hussain College, Jawaharlal Nehru Marg (Old Minto Road) New Delhi–02.
- 2.2 Following documents must be submitted along with the Tender document failing which the tender will not be accepted:-
 - > Letter of submission of tender along with rates in the format as given at Annexure-II.
 - > Tender document with all pages duly signed and embossed with official seal.
 - Demand Draft of Rs.8000/- towards Earnest Money Deposit.
 - Authorized Dealer certificate of manufacturer of reputed brand of Ultra HD Slim LED Display.

2.3 Evaluation Criteria:-

- (i) Rate shall be quoted inclusive of all taxes and duties and nothing extra shall be paid on that account.
- (ii) Agency/Firm/Company has to carry out any other miscellaneous job (like wall mounting arrangements with necessary accessories) required for completion of work. Rate shall be quoted accordingly and nothing extra shall be paid on that account.
- (iii) L1 shall be decided on the total amount quoted.
- 2.4 The tenderer shall abide by the "Schedule of Requirement and terms & conditions" as mentioned in Section 4 of this tender. It must be clearly understood that the prices quoted in the tender are to include everything required to be done for the proper completion of the job as per the "Schedule of Requirement and terms & conditions" mentioned in the tender. The prices quoted should be in Indian Rupee.
- 2.5 The Purchaser does not bind itself to accept the lowest or any tender or to assign any reason for non-acceptance.
- 2.6 Offers received through Telegraphic/Fax/E-Mail will be treated as defective, invalid and rejected.
- 2.7 Award of Contract: After evaluation of the bids received, the Purchaser would award Contract to the lowest bidder, whose bid is technically acceptable and meets the eligibility requirement.

Section: 3. - Eligibility Criteria for Tenderers

The tenderer should be an authorized dealer certificate of manufacturer of reputed brand 74" Range Ultra HD Slim LED Display.

Section: 4 - Schedule of Requirement and Conditions of Contract

- 4.1 Upon award of the Contract, the Contractor shall deliver, install & commission the Television in Telecom Regulatory Authority of India, Mahanagar Doorsanchar Bhawan, Near Zakir Hussain College, Jawaharlal Nehru Marg (Old Minto Road) New Delhi–02 Building within 15 days time.
- 4.2 **Arbitration:** In the event of any dispute relating to the import or meaning of any terms and conditions which could not be solved amicably by the parties, may refer the matter to the Sole Arbitrator to be appointed by TRAI on the request of either of the parties for arbitration in consonance with the provisions of the Arbitration and Conciliation Act, 1996(Act 26 of 1996), on the designated reference in dispute.
- 4.3 **Governing Laws & regulation:** All legal proceedings shall be under the jurisdiction of courts situated in the National Capital Territory of Delhi. This Agreement shall be covered and construed in accordance with Laws of India including without Contract Termination.
- Termination for Convenience: TRAI reserves the right to terminate by prior written notice, the whole or part of the contract. The notice of termination shall specify that termination be for TRAI's convenience, the extent to which performance of work under the contract is terminated and the date on which such termination becomes effective.
- 4.5 **Force Majeure : -** Notwithstanding the provisions of the contract, the Contractor shall not be liable for forfeiture of its EMD, Penalty or termination for default; if and to the extent that, it's delay in performance or other failure to perform its obligations under the contract is the result of an event of standard TRAI Force Majeure.
- 4.6 **Sub-contracting:-** No sub-contracting is allowed.
- 4.7 **Payment Terms & Schedule: -** The bills shall be prepared by the contractor in duplicate and submitted to TRAI, New Delhi. Payment shall be made on following conditions:
 - a) All payments to the firm shall be made subject to deduction of TDS (Tax deduction at Source) as per the Income Tax Act 1961 and other taxes if any as per the Government of India Rule.
 - b) Payment will be made to the firm on successful delivery and installation of Television in the Building of TRAI, New Delhi.
