Seminar on "5G Mobile Technology" at Gandhinagar on 4th January 2024 by RO Hyderabad



TRAI conducted a Seminar on the "5G Mobile Technology, Deployment challenges, use cases and Network Security" at Chennai, Tamilnadu on 04th January 2024.

The session started with a welcome address by Shri B. Praveen Kumar, ITS, Advisor, TRAI, RO, Hyderabad. He welcomed all the participants and gave details about the growth of telecom sector in the country and role of TRAI in promoting the same. He mentioned the importance of 5G Technology in respect of enhanced speed, low latency and its applications in different sectors like Agriculture, Education, Health and growth of Economy. He had also stressed the importance of security during the course of adoption of 5G Technology. He mentioned about Regulations and recommendations of TRAI to Government of India.
