TRAI organized a Seminar on "Digital inclusion: Ubiquitous access to information communication technology" at Raipur conducted by RO Bhopal. Eminent speakers and wide range of participants from Central & State Govt, Industry, CSC, faculty, and students of various educational institutions took part in the seminar.



Shri Vinod Gupta, Advisor TRAI in his Welcome address said that the mission of the Telecom Regulatory Authority of India is to create and sustain conditions for the growth of telecom services in the country in such a manner and at such a pace, which can enable India to play a leading role in the emerging global information society. Advisor (CA, QoS and IT), TRAI the Special Guests and Speaker on the occasion, in his address has talked about Digital Inclusion, Key enablers of digital inclusion, India's Revolutionary Journey towards Digital Inclusion, Identifying the Gaps such as Rural-Urban Gap, Gender Gap, Gaps in States and UTs.

Ms. Vandana Sethi, Advisor (Admn. & IR), TRAI and Dr. Arzad Alam, Associate Professor, IIT Bhilai has talked about Emerging Technologies for driving Digital Inclusion viz. 5G technology and use cases, 5G Fixed Wireless Access (FWA), Satellite internet, high-altitude platform station, Wi-Fi Access point etc..

This seminar also focused on Innovation and Entrepreneurship Alliance for Digital Development/ Digital inclusion for Micro, Small and Medium Enterprises and government initiative towards digital inclusion/Digital India Program.

Workshop

TRAI conducted Regional Capacity Building Workshop for CAGs of North region on 23rd November. 2023 in Srinagar, Jammu and Kashmir





The capacity building workshop is a platform wherein TRAI directly interacts with CAGs and TSPs to understand their consumer centric activities to take consumer outreach activities to the next level. In this workshop CAGs and TSPs of Delhi, UP, Uttarakhand, Himachal Pradesh, Jammu & Kashmir participated.

Sh. A.K Singh, Advisor (CA&IT) welcomed the participants and explained the purpose and agenda of the workshop. In his welcome address he explained the importance of the workshop for strengthening the CAGs and their effective participation in holding consumer awareness programs. He welcomed the CAGs and TSP representatives of northern region. He also welcomed the expert speakers from DoT and Cyber Crime wing of J&K Police.

Sh. V. Raghunandan, Secretary, TRAI and presiding member of CUTCEF inaugurated the workshop and delivered keynote address. He shared several consumer centric initiatives of TRAI and has given guidance to CAGs and TSPs for effective creation of awareness. He also asked TSP representatives to put more effort in curbing unsolicited calls/ messages. He mentioned that Fraudulent messages have camouflaged into commercial communication which is a severe problem today. All stakeholders should work together to curb this menace. TSPs have been mandated to take explicit digital consent without relying on principle entities. Secretary, TRAI asked TSPs to look at their DND registration/ Complaint mechanism and its easy accessibility to help subscribers to lodge complaints. The advantage of the DLT platform may be well utilized by effectively registering UCC complaints through TSPs. Quality of Service in J&K area is another important aspect that service providers need to look into.

Sh. P. Balaji, Chief regulatory and corporate officer, Vodafone Idea Limited, shared his thoughts on the occasion. He lauded the efforts of TRAI for the past several years to bring various consumer protection measures for the consumers. Recent efforts of TRAI in mandating Digital consent, Monthly packs and reducing the bill shocks for international consumers are to name a few. He expressed gratitude for the constant guidance of TRAI in this regard to TSPs.

Sh. Musadiq Majid Basu, Superintendent of Police shared his experiences on this year theme "Digital Frauds through Spams and safety lies in Awareness" and answered queries of participants on the cybercrimes.

In September 2023, 12.65 million subscriber requests were made for MNP. By the end of September 2023, a total of 890.08 million consumers availed the MNP facility since its implementation.

On **09**th **November 2023**, TRAI floated EOI to invite proposals from eligible companies/Limited Liability Partnerships (LLP)/Partnership firms/proprietorship firms registered with the Institute of Chartered Accountants of India (ICAI) as audit firm (hereinafter referred to as the "Audit Agency" or "Applicant") for empanelment in the panel of Auditors to carry out audit of Digital Addressable Systems in accordance with the TRAI's regulatory framework for Broadcasting and Cable Services.

TRAI released the updated list of panel of Auditors to carry out audit of Digital Addressable Systems (DAS) on **08**th **November 2023**, vide which two Auditors M/s AMAA & Associates and M/s Borkar & Muzumdar were added. The total number of auditors empanelled by TRAI to carry out the audit of DAS as on **30**th **November 2023** are 50.
