2 Findings of the independent agency on Quality of Service

2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers, namely, M/s BSNL, Aircel, Airtel, Idea, LOOP, RELIANCE, S TEL, TATA INDICOM and Vodafone was conducted during the period from April, 2011 to June, 2011.
