2 Findings of the independent agency on Quality of Service

2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers, namely, M/s Aircel, Airtel, BSNL, Etisalat, Idea, MTS, RELIANCE CDMA, RELIANCE GSM, S TEL, TATA DOCOMO, TATA INDICOM, UNINOR and Vodafone was conducted during the period from April, 2011 to June, 2011. Service Provider's performance on the selected Key Parameters in respect of cellular mobile telephone service based on one month data verification is annexed at "A"
