TRAI had engaged independent agency to conduct Network audit for the assessment of Quality of Service being provided by the service providers during the period from April, 2011 to June, 2011. The main findings of the reports are given below:-

2 Findings of the independent agency on Quality of Service

2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers, namely, M/s Aircel, Airtel, Etisalat, Idea, Loop, BSNL, RCOM GSM, TATA GSM, Videocon, Vodafone, HFCL CDMA, RCOM CDMA and TATA CDMA was conducted during the period from April, 2011 to June, 2011. Service Provider's performance on the selected Key Parameters in respect of cellular mobile telephone service based on one month data verification is annexed at "A"
