Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up the post of Principal Advisor at its Headquarter in New Delhi on deputation on foreign service terms, <u>initially</u> for a period of two years. The required qualification and experience for the said post are given below:-

- 3. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17th June, 2010, as amended from time to time. The maximum age for appointment on deputation shall in no case exceed 58 years on the last date of submission of applications in TRAI.
- 4. The applicants fulfilling the eligibility criteria and having relevant experience, etc., may apply through **online mode only** on URL: https://vacancies.trai.gov.in.
- 5. All the Ministries/Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies of Government of India are requested to forward duly attested hard copy of filled online application form (downloaded from https://vacancies.trai.gov.in) along with attested copies of ACRs/APARs for the last five years, vigilance/disciplinary clearance and cadre clearance of eligible candidates, whose services could be placed at the disposal of the Authority immediately in the event of their selection.
