Officers of the Central Government, Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post or (ii) officers in Senior Time Scale with five years of regular service in that grade or (iii) Group A officers with ten years of regular service in Group A of which at least five years of continuous service shall be in the Senior Time Scale. <u>Essential:</u> A Degree in Business Administration/Commerce/Engineering/ Science /Humanities from a recognized University/institution. <u>Age:</u> Not exceeding 56 years on the date of closing of applications.

Note : Persons holding the post having Pay Band-4, Rs. 37400-67000 + GP Rs.8700 on regular basis or (ii) officers in Junior Administrative Grade with five years of regular service in that grade or (iii) Group A officers having sixteen years of regular service in Group A of which at least five years of continuous service in the Junior Administrative Grade may also apply and in case of selection he/she shall be considered for appointment as Joint Advisor in the pay band-4, Rs. 37400-67000 + GP Rs. 8700/-.
