2. **Eligibility conditions:**

(i) Officials of the Central Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post or (ii) ten years of service in the pay scale of Rs.3050-4590 (pre-revised)/PB-1 Rs.5200-20200 + GP 1900 (revised) with working knowledge of computers.

(ii) The candidate should be preferably in the age group of 30-35 years as on the last date prescribed for submission of the application.

Persons having experience in areas of Office Management, Establishment and Service Matters, Personnel matters and claims, Media Management, Public Relation, RTI Cases, Budget related areas, handling of Legal & Litigations cases, collection and compilation of Economic & Financial data, formulation of regulations of statutory bodies, handling of consumer grievances etc. will be preferred.
